The Chairperson-NRC called the meeting to order and welcomes all the members and introduced them to all persons working with the NRC to the new Committee. Chairman-NRC and all the members conveyed their greetings and best wishes

to Prof. Akhtar Siddiqui for taking over as National Chairman of NCTE. After this the regular agenda was taken up. The Regional Director presented a Power point presentation regarding the functioning and status of applications of NRC.

PRELIMINARY DISCUSSIONS

Regarding sending of Minutes of NRC, the Committee decided that henceforth, the soft copy of the Minutes in the form of CD is to be sent to all the members of NRC except Dr. M. C. Mathur, who desired hard copy of the minutes, a hard copy of the minutes will be provided to him.

The Committee decided that there should be a liason between the Universities / NRC/ State Government Agencies etc in order to sort out the problems mutually and explore areas of mutual co-operation. The visiting team members must be briefed about their jobs assigned to them and their selection should be meticulous.

The NRC received notice on No Objection in number of cases from the Haryana Government. Most of them were related to the projection of manpower requirement suggesting that no more recognition be given. But at the same time there was a letter from the State Government wherein they have stated that there is no need of NOC for Under Graduate Level for colleges running on Self Finance Basis. Considering the incongruity and also related to a State Level projection of manpower requirement whereas we are dealing with the national level, the NRC approval to be continued with the cases and kept their verdict maintaining senonomy and concurrence with all the states that come under the NRC.

The Original file of the institutions, Visiting Team Reports, other related documents, Video CD, Act of NCTE, 1993, Regulations and guidelines of NCTE published from time to time were laid on the table of the Committee.
