## **Preliminary discussions**

The Committee noted that multipurpose hall should have the seating capacity for 150 persons. The committee resolved that each person requires at least 9 sq.ft area to sit comfortably. Therefore, the total area of 1350 sq.ft is required for seating at least 150 persons. At least 50 sq.ft is required for Dias. **So the Committee resolved that multipurpose hall should have a minimum area of 1400 sq.ft.**
