In order to achieve the above objective, all the teacher education institutions recognized by the Northern Regional Committee of NCTE are requested to upload the data in respect of their institution viz. institution's basic details; teachers' details; details of non-teaching staff; programmes conducted; students enrolled in these programmes; examination results; financial information; infrastructure, scholarships, loans and accreditation, in Data Capture Format (DCF-III) on the National Information Centre (NIC) Portal (URL: <http://aishe.gov.in>) so that preparation to collect reliable and comprehensive database can be finalized by NEUPA for All India Survey of Higher Education.

The teacher education institutions are further requested to send a confirmation letter to Dr. Anil Shukla, Deputy Secretary, NCTE Hqrs., New Delhi after uploading the information on NIC Portal.

Hence, you are requested to coordinate with all teacher education institutions in your region to complete the pending process of uploading of data in Data Capture Format (DCF-III) on the National Information Centre (NIC) Portal ([URL:http://aishe.gov.in](http://aishe.gov.in)) expeditiously so that preparation to collect reliable and comprehensive database can be finalized by the National University Educational Planning and Administration (NUEPA) for All India Survey of Higher Education.

It is requested that all the Teacher Training Institutions (TTIs) may be directed that after filling the complete information in Data Capture Format (DCF-III) on the National Information Centre (NIC) Portal, they may also send a confirmation letter to National Council for Teacher Education (NCTE), Headquarter, New Delhi.


Please refer to the correspondence resting with your letter No. 47-15/2011/NCTE/CDN dated 1st November, 2011 addressed to Directors of SCERTs in the States regarding the All India Survey of Higher Education requesting them to facilitate the process of uploading of data by the individual Teacher Training Institutions (TTIs) in DCF-III on the NIC Portal. Based on your letter, we had sent a detailed communication on 28.12.2011 to all the SCERTs in the country outlining the process of registration and data uploading by the individual TTIs in DCF-III on the NIC Portal. This was followed by reminders dated 17.03.2012, 12.04.2012 and 06.06.2012.

From the NIC Portal, it is seen that as on 5th June, 2012, out of 5966 TTIs, about 1573 have uploaded their respective data in DCF-III, and the remaining are yet to upload their data.

I shall be grateful if you could write to the Directors of SCERTs once again impressing upon them the urgency of the matter so that work relating to data collection and its uploading in DCF-III on the NIC Portal by the TTIs is completed at the earliest.
