This has reference to the subject cited above, institution has submitted an application in online mode on 30.12.2012 and physical application has been received in the office of NRC on 04.01.2013 for D.El.Ed. course in the proposed institution Wisdom College of Elementary Education, Plot / Khasra Number -346, Street Number-NA, Village- Kidhara, Post Office – Harduaganj, Tehsil/Taluka-Koil, Town/City- Aligarh, District – Aligarh, State – Uttar Pradesh, Pin Code –202001. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulation 2009. It is informed that on preliminary perusal of the documents submitted with your application viz a viz provisions of the NCTE Regulation, 2009, your application is found deficient on the following points which are as under:-

i. Certified copy of registered land documents issued by the competent authority (office of Registrar/Sub Registrar) as required under provision of NCTE regulation, 2009 has not submitted.

i. The institution has submitted approved building plan approved by Gram Pradhan but name of

proposed course is not mentioned on building plan.

iii. Notarized copy of change of land use certificate issued under clause 143 of UP land Act by the

Competent Authority has not submitted.

iv. The Institution has submitted two application ie NRCAPP 6855& NRCAPP 6893 for recognition of B.Ed. & D.El.Ed. respectively on the same land ie Khasara No. 346. As per provision of clause 8(2) of NCTE Regulation, 2009. Only one course for the basic unit can be consider for grant recognition. Hence, Institute clarify that which application may be considered.

The specific information of land/ building, demarcated area as required in clause 8(7)(ii) and information required under clause 8(2) 8(3) of NCTE Regulations 2009 and information related to resolution of the society for opening the said course not for profit etc has not given by the institution hance the same is required from the institution in the affidavit(format of the affidavit is enclosed

herewith).

2. You are advised to remove/make good of the above deficiencies within a period of 60 days failing which your application will be treated as rejected and closed. It may be noted by the institution it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

3. Your reply/representation along with all necessary documents accompanied with an Affidavit in support of the reply of the above points must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Rules & Regulations.

4. Reply in piece meal will not be accepted. Since application has been processed as per clause. Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/processing fee cannot be made at any stage of application, whatsoever be the case.
