- 2. Land document submitted were not certified by competent authority. Certified copy of registered land documents issued by the competent authority is to be submitted.
- 3. The Memorandum showing names of the office bearers with designation not submitted.
- 4. The address of the Society does not match with the application.
- 5. The information at S.No.5 of the Affidavit not filled up. i.e. the No. and the date of the CLU not mentioned.
- 6. Building plan approved by the competent authority not submitted.
- 7. The Name and Address of the institution, Khasara No./Plot no., Total land area, built up area and name of the course not shown in the building plan.
- 8. Date of registration of land documents in the Affidavit is not mentioned.
- 9. The institution is also required to submit an Affidavit on Rs 100/- stamp paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of NCTE Regulations, 2009 and Page 2,4 and 5 of the online application form.
- 2. You are advised to remove /make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

3. Your reply/representation along with all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTS Act. Rules & Regulations.
