- You are advised to remove/make well of the above deficiencies within a period of 60 days failing which your application will be treated as rejected and closed. Your reply/representation along with all necessary documents accompanied with an Affidavit in support of the reply of the above points must be submitted within 60 days of issue of this letter, failing which appropriate action

will be taken as per provisions of the NCTE Rules & Regulations.
