The Society/Trust has submitted an application through online mode on 29.12.2012 and physical application has been received in the office of NRC on 04.01.2013 for B.Ed course in the proposed institution, Ch Charan Singh Institute of Education Women, Plot/Khasara No. -175/956, Street No. - Chhaprauli, Village-Baraut, Post Office -Baraut, Tehsil/Taluka - Baraut, Town/City -Baraut, State - UP, Distt. -Bagpat, UP - 250611. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations 2009, your application is found deficient on the following points which are as under:-

- The institution has not submitted the certified copy of the registered land documents issued by the competent authority under provision of clause 8 (7) (i) of NCTE, Regulations, 2009.
- The building plan submitted by the institution did not show the name of the course for which the building is meant for by the institution. Therefore, the institution is require to submit building plan in blue print approved by the competent civil authority clearly showing the name of the institution, course, Khasara/Plot No., total land area & built up area, multipurpose hall, different resource centre, class room, library etc. as per provisions of the NCTE Regulations, 2009.
- The building plan has been signed/certified by the "Awar Abhiyanta RES". The institution is require to submit a certificate from the concerned authority to the effect that the construction work of the building of the institution comes under their jurisdiction and "Awar Abhiyanta, RES" is authorized to approved the building plan of the institution.
- The institution submitted a copy of the purported documents as Land Use Certificate which has been issued by the SDM, the same is also not notarized. The institution is required to submit a notarized copy of the Land Use Certificate issued by the competent authority under Section 143 of UP Land Act.
- As per the details available in the application submitted by the institution, the institution is running a School. The institution is required to clarify the same and submit the following:-
 - A certificate from the DEO that no other educational course/school is running presently in the land & building of the proposed teacher training institution alongwith a certificate from concerned Tehsildar/Revenue Authority to the effect that the land & building is exclusively used for running the proposed teacher education course as per clause 8 (7) (ii) of the NCTE Regulations, 2009 or
 - in case where the institution is running other educational programme, a copy of the demarcated building plan in blue print (ii) approved by the competent civil authority clearly showing the name of the institution, course, Khasra/Plot No., total land area & built up area, multipurpose hall, different resource centre, class room, library etc. alongwith a certified copy of the site plan showing the existing running educational programme & proposed teacher education programme as per provisions of clause 8 (7) (ii) of the NCTE Regulations, 2009 duly verified by the concerned Tehsildar/SDM.
- The affidavit submitted by the institution did not show the complete details. Column No. 5 is not completed filled in (CLU information are not provided by the institution). Therefore, the institution is required to submit a complete affidavit in the prescribed format on Rs.100/- stamp paper duly attested by oath commissioner or Notary Public in the prescribed form stating the precise location of the land (village, district, state etc.) the total area in possession, the permission of the competent authority to use the land for education purpose and mode of possession i.e. ownership or lease as required under provisions of Section 7 (1) of the NCTE Regulations, 2009.
- The details regarding land & building mentioned in the Affidavit, land documents, building plan & CLU are not fully matching with each other. The institution is required to clarify the same.
- The institution is required to submit an Affidavit on Rs.100/- stamp paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8 (7) (ii) of the NCTE Regulations, 2009 and page 2,4,5 of the online application form.
- You are advised to remove /make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules-& Regulations.

Your reply/representation along with all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.

Reply in piecemeal will not be accepted. Since application has been processed as per clause 6 of NCTE Regulations, 2009, hence, once the application is duly processed by this office, the claim for refund of application /processing fee cannot be made at any stage of application, whatsoever
