This has reference to the subject cited above, institution has submitted an application in online mode on 30.12.2012 and physical application has been received in the office of NRC on 31.12.2012 for B.Ed. course in the proposed institution by Chunnilala College of Education, Plot / Khasra Number -1335, Street Number-Sahpau, Village- Sahpau, Post Office- Sahpau, Tehsil/Taluka-Sadabad, Town/City- Sahpau, District – Mahamaya Nagar, State – Uttar Pradesh, Pin Code –281306. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulation 2009. It is informed that on preliminary perusal of the documents submitted with your application viz a viz provisions of the NCTE Regulation, 2009, your application is found deficient on the following points which are as under:-

Original FDRs of Rs. Five Lakh and Three Lakh of nationalized bank towards Endowment fund and Reserved Fund respectively has not submitted.

2. Certified copy of registered land documents issued by the competent authority (office of Registrar/ Sub Registrar) as required under provision of NCTE regulation, 2009 has not submitted.

The institution has submitted approved building plan approved by Gram Panchyat but the Khasra no/plot no of land and total build up area for the proposed course has not mention.

Affidavit in the prescribed format on Rs.100/ stamp paper duly attested by oath commissioner or Notary Public as required under provision of section 7(1) of NCTE, Regulation, 2009 has not been submitted.

The name of authorized applicant in the application form doesn't appear in the bye-laws of the society. The specific information of land/ building, demarcated area as required in clause 8(7)(ii) and information required under clause 8(2) 8(3) of NCTE Regulations 2009 and information related to resolution of the society for opening the said course not for profit etc has not given by the institution hance the same is required from the institution in the affidavit (format of the affidavit is enclosed herewith).

- 2. You are advised to remove/make good of the above deficiencies within a period of 60 days failing which your application will be treated as rejected and closed. It may be noted by the institution it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.
- 3. Your reply/representation along with all necessary documents accompanied with an Affidavit in support of the reply of the above points must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Rules & Regulations.
