1. Originally notarized change of land use (CLU) certificate issued by SDM under section 143 of UP Land Act not submitted.

2. The proposal of the college name is Suyash Teachers Training College whereas the buildings plan in the favor of Suyash Nyas Teachers Training College.

3. Mode of land is not clear as per affidavit of Rs. 100/-.

4. In the affidavit of Rs. 100/- the institute name is Suyash Technical Training College of Sr. No. 2, whereas proposed college name is Suyash Teachers Training College.

5. The proposed of the college of plot no. 128, 121, 109,91 whereas the college is situated of plot no.

78kh, 89 ka, 90kh, 91kha, 109,116,121,122.

6. The college building in situated of plot no. 78kh, 89 ka, 90kh, 91kha, 109,116,121,122 is not matching

with application form as per building plan.

7. The institution is required to submit an Affidavit of Rs. 100/- stamp paper as per the format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (ii) of the NCTE Regulations, 2009 & page 4 & 5 of the Online Application form.

You are advised to remove/make good of the above deficiencies within a period of 60 days failing which your application will be treated as rejected and closed. It may be noted by the institution it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules &
