The Society/Trust has submitted an application through online mode on 20/12/2012 and physical application has been received in the office of NRC on 24/12/2012 for B.ED course in the Khalsa College, Plot/Khasara No- 172,174,176,177,178, Plot No. – 172, 174, 176,177,178, Street Number- NH-25, Vili- Chamrauli, Post Office-Chamrauli, Teh/Taluk- Hasan Ganj, Town/City- Unnao, Dist- Unnao, State-UP, Pin-209831. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application vizaviz provisions of the NCTE Regulations 2009, your application is found deficient on the following points which are as under:-

- 1. Certified copy of registered land documents issued by the Registrar/Sub-registrar to be submitted. The institution has submitted only Khatoni.
- 2. Originally notarized change of land use (CLU) certificate issued by SDM under section 143 of U.P. Land Act not submitted.
- 3. The DD submitted by the institution for Rs-50100/- towards processing fees is returned herewith as the same has expired. The DD may be got revalidated and re-submitted.
- 4. The information at S.No.5 of the Affidavit not filled up. i.e. the No. and the date of the CLU not mentioned.
- 5. The building plan does not show for which teacher education course the building has been constructed.
- 6. The Plot. /Khasara nos. not shown in the building plan.
- 7. The built up area given in the building plan does not match with the application.
- 8. The address of the trust not mentioned in the Trust deed.
- According to NCTE Regulation, 2009, three sets of hard copy of the on-line application are to be submitted.
 The institution has submitted three sets of hard copy of the on-line application, but the two sets do not have any supporting documents.
- 10. The institution is also required to submit an Affidavit on Rs 100/- stamp paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of NCTE Regulations, 2009 and Page 2,4 and 5 of the online application form.
- 2. You are advised to remove /make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.
- 3. Your reply/representation along with all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.
- 4. Reply in piecemeal will not be accepted. Since application has been processed as per clause 6 of NCTE Regulations, 2009, hence, once the application is duly processed by this office, the claim for refund of application /processing fee cannot be made at any stage of application, whatsoever be the case.
