The Society/Trust has submitted an application through online mode on 22/12/2012 and physical application has been received in the office of NRC on 24/1/2013 for M.ED course in the Vimla Vikram Mahavidyalaya, Plot/Khasara No-606,607,608, Plot No. 606, Street Number-0, Vill-Pachperwa, Post Office- Balrampur, Teh/Taluk-Tulsipur, Town/City- Balrampur, Dist- Lucknow (UP), State-UP, Pin-272106. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations 2009, your application is found deficient on the following points which are as under:-

- 1. Originally notarized change of land use (CLU) certificate issued by SDM under section 143 of U.P. Land Act not submitted.
- 2. The Name of the institution and total land area given in the land document does not match with the application.

3. The date of registration of land documents not correct in the information at S.No.2 of the affidavit.

4. The building plan submitted by the institution is for plot no. 607,608, whereas in the application the plot nos are 606,607&608.

5. Total plot area and Built up area given in the building plan does not match with the application.

6. The FDRs of Rs.5 lakhs and Rs.3 lakhs submitted by the institution are not from the nationalized bank. As per NCTE Regulations 2009, the FDRs are to be submitted from the nationalized bank. Hence, The FDRs submitted by the institution are returned herewith.

7. NAAC accreditation certificate not submitted.

8. The institution has also applied for BTC (D.El.Ed) course vide Application No. NRCAPP 2391, which is pending. In case of recognition for this course, only one application shall be processed as per clause 8(2) of the NCTE Regulations, 2009. Hence, clarification be given.

9. The institution is also required to submit an Affidavit on Rs 100/- stamp paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of NCTE Regulations, 2009 and Page 2,4 and 5 of the online application form.

- 2. You are advised to remove /make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.
- 3. Your reply/representation along with all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.
- 4. Reply in piecemeal will not be accepted. Since application has been processed as per clause 6 of NCTE Regulations, 2009, hence, once the application is duly processed by this office, the claim for refund of application /processing fee cannot be made at any stage of application, whatsoever be the case.
