The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulation 2009. It is informed that on preliminary perusal of the documents submitted with your application viz a viz provisions of the NCTE Regulation, 2009, your application is found deficient on the following points which are as under:-

- 1. Certified copy of registered land documents issued by the competent authority (Office of Registrar/ Sub Registrar) as required under provision of NCTE Regulation, 2009 has not submitted.
- 2. The information given in affidavit regarding possession of the land on ownership basis or lease basis is not clear.
- 3. The copy of approved building plan indicating name of institution, name of course, khasra No./Plot No. of land, total land area and earmarked built up area, size of multipurpose hall and class rooms etc for the proposed course is required to be submitted.
- 4. Originally notarized change of land use (CLU) certificate issued by SDM under section 143 of UP Land Act not submitted.
- 5. The institution is required to submit an Affidavit of Rs. 100/- stamp paper as per the format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (ii) of the NCTE Regulation 2009 & page 4 & 5 of the Online Application form.
- 6. The institution has submitted two application i.e file code no. APP4241 & 4248. Which is against as per clause 8(2) (3) of Regulation 2009.
- 2. You are advised to remove/make good of the above deficiencies within a period of 60 days failing which your application will be treated as rejected and closed. It may be noted by the institution it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

- 4. Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/processing fee cannot be made at any stage of application, whatsoever be the case.
