will be taken as per provisions of the NCTE Rules & Regulations.

Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of Regulation 5. 2009, hence once the application is duly processed by this office, the claim for refund of application/processing fee cannot be made at any stage of application, whatsoever is the case.
