It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:-

- Originally notarized change of land use (CLU) certificate issued by SDM under Section 143 of U.P. Land Act not be submitted.
- Information at S.No. 5 of the affidavit not filled up i.e. the no. and date of CLU certificate to be mentioned. ii.

The built-up area given in the building plan does not match with the application. iii.

Plot/Khasara no. & Land area given in the Land document does not match with the application. iv.

Land document submitted is not certified by Competent Authority. Certified copy of land documents registered by Registrar/Sub-Registrar is to be submitted.

FDRs of Rs. 5 lakhs towards endowment fund and Rs. 3 lakhs towards reserve fund of Gramin Ban't in νi. original is returned herewith as it is not of the nationalized bank. FDRs of nationalized bank is to be submitted.

The institution is also required to submit on Affidavit on Rs 100/- Stamp Paper as per format enclosed in νii. support of information required as per clause 8(2), 8(3) and 8(7) (2) of the NCTE Regulations, 2009 and Page-2, 4 and 5 of the online Application form.

You are advised to remove/make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

Your reply/representation alongwith all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.

Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of the NCTE Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/ processing fee cannot be made at any stage of application, whatsoever be the case.
