The Society/Trust has submitted an application through online mode on 28/12/2012 and physical application has been received in the office of NRC on 31/12/2012 for B.ED course in the Shri Jagjeet Sharma Suman Lata Om Cilty Convent Balika Degree College, Plot/Khasara No-883, Plot No. 151, Street Number- 6, Vill- Khurja, Post Office- Khurja, Teh/Taluk- Khurja, Town/City- Khurja, Dist- Bulandshahr, (UP), State-UP, Pin 203131. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations 2009, your application is found deficient on the following points which are as under:-

- The name of the institution and Society given in the land document does not match with the application. I.
- Clear and legible blue Print of the building plan duly approved by the competent authority/local body clearly indicating the name & address of the institution, proposed course, total land area, built up area for the proposed course to be submitted. The building plan submitted is not legible and it is for school building,
- CLU submitted is not originally notarized. Originally notarized change of land use (CLU) certificate issued by SDM under section 143 of U.P. Land Act be submitted.
- The name of the institution given in the CLU certificate does not match with the application.
- Plot/Khasara no. given in the land document and CLU certificate does not match with the application.
- The name of the society and total area of land given in the affidavit does not match with the application.
- The information at S.No.5 of the Affidavit not filled up. i.e. the date of the CLU not mentioned.
- The name & address of the society given in the registration certificate and bylaws does not match with the
- The date of registration of land in the affidavit do not match with the application.
- The institution is also required to submit an Affidavit on Rs 100/- stamp paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of NCTE Regulations, 2009 and Page 2,4 and 5 of the online application form.
- You are advised to remove /make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.
- Your reply/representation along with all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.

Reply in piecemeal will not be accepted. Since application has been processed as per clause 6 of NCTE Regulations, 2009, hence, once the application is duly processed by this office, the claim for refund of application /processing fee cannot be made at any stage of application, whatsoever be the case.
