The Society/Trust has submitted an application through online mode on 28/12/2012 and physical application has been received in the office of NRC on 31/01/2013 for B.Ed course in the proposed institution, Arihant Educational Institute, Plot/Khasara No- 1022, 977, 1, Vill- Sikanderpur, Post Office- Kakua, Tehsil-Kheragarh, Distt- Agra, Pin Code-282001, UP. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:-

- i. The address of society in the registration certificate, land documents & FDRs does not match with the application.
- ii. Plot/khasara nos. in the application does not match with the land documents.
- iii. Khasara nos./plot no. in the building plan do not match with the application.
- iv. Building plan does not show for which teacher education course the building has been constructed.
- v. The information at s.no.5 of the affidavit is incorrect i.e. the no. & date of CLU certificate is to be mentioned.
- vi. Address of the institution in the affidavit does not match with the application.
- vii. No certified land document has been submitted in r/o plot no. 977 as mentioned in the application.
- viii. The land area in r/o plot no. 1022 is only 1537sq.mt, which is less as per norms for the course.
 - ix. Document from the competent authority indicating that the plot/khasara nos. 1022 and 997 are adjacent to each other to be submitted.
 - x. The CLU certificate submitted is not notarized and is in r/o plot no.997, which does not match with the application. The CLU shows the name of Moolchand as owner of the land and not the society/institution.
 - xi. Plot no. 1022kh in the affidavit does not match with the application.
- xii. The details of registration of land in the affidavit do not match with the application.
- xiii. The institution is also required to submit on Affidavit on Rs 100/- Stamp Paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of the NCTE Regulations, 2009 and Page-2, 4 and 5 of the online Application form.
- 2. You are advised to remove/make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

3. Your reply/representation alongwith all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.

4. Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of the NCTE Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/processing fee cannot be made at any stage of application, whatsoever be the case.
