The Society/Trust has submitted an application through online mode on 24/12/2012 and physical application has been received in the office of NRC on 27/12/2012 for B.ED course in the RC Bind Mahavidhayalya, Plot/Khasara No-83kh,82k, Plot No. 83kh,82k, Street Number-Reewa Road, Vill-Bhorsar, Post Office-Amoi, Teh/Taluk- Sadar, Town/City- Mirzapur, Dist- Mirzapur (UP), State-UP, Pin-231001. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations. 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations 2009, your application is found deficient on the following points which are as under:-

- 1. Originally notarized change of land use (CLU) certificate issued by SDM under section 143 of U.P. Land Act not submitted.
- Land documents (Gift deed) submitted is not certified by competent authority. Certified copy of registered land documents issued by the Registrar/Sub-registrar not submitted.
- 3. The building plan submitted is not duly approved by Competent Govt. Authority/Local body.
- 4. Built up area given in the building plan does not match with the application,
- 5. The plot/khasara no. given in the Building Plan, Affidavit does not match with the application.
- The Name and address of the Society given in the FDRs does not match with the application.
- The information given at S.No.5 of the Affidavit is not filled up. i.e. the No. and date of CLU certificate issued by SDM under section 143 of the U.P. land Act is to be filled.
- 8. Original Challan towards deposit of processing fees not submitted.
- 9. The building plan does not show for which teacher education course the building has been constructed.
- 10. The address of the society given in the Registration certificate and bylaws does not match with the application.
- 11. The institution is also required to submit an Affidavit on Rs 100/- stamp paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of NCTE Regulations, 2009 and Page 2,4 and 5 of the online application form.
- You are advised to remove /make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.
- Your reply/representation along with all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.
- Reply in piecemeal will not be accepted. Since application has been processed as per clause 6 of NCTE Regulations, 2009, hence, once the application is duly processed by this office, the claim for refund of application /processing fee cannot be made at any stage of application, whatsoever be the case.
