This has reference to the subject cited above, institution has submitted an application in online mode on 30.12.2012 and physical application has been received in the office of NRC on 31.01.2013 for B.Ed. course in the proposed institution Dr Ankit Singh, Plot Number—423, Street /Road—423, Village/Town/City-Bhua-Kaintheri, Post Office—Badagaon, Tehsil/Taluka-Orai, Town/City-Orai, District—Jalaun, State—Uttar Pradesh, Pin Code—285001. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulation 2009. It is informed that on preliminary perusal of the documents submitted with your application viz a viz provisions of the NCTE Regulation, 2009, your application is found deficient on the following points which are as under:-

- 1. Certified copy of registered land documents issued by the competent authority (office of Registrar/Sub Registrar) as required under provision of NCTE regulation, 2009 has not submitted.
- 2. As per copy of land documents submitted with the application the land is in favour of Shri Ram Krishna Memorial Degree College whereas the name of Institute mentioned in the application is Dr.Ankit Singh hence land is not in favour of institute/society as required in the clause 8 7(i) of NCTE Regulation 2009.
- 3. The institution has submitted approved building plan approved by Gram Pradhan but the Khasra no/plot no of land and for the proposed course has not mention.
- 4. Notarized copy of change of land use certificate issued under clause 143 of UP land Act by the competent authority has not submitted.
- 5. The Registration for society is valid up to 25.07.2012. Hence renewal of the Registration of the society is required.
 - The proposal of the college name is not clear as per application from.

The specific information of land/building, demarcated area as required in clause 8(7)(ii) and information required under clause 8(2) 8(3) of NCTE Regulations 2009 and information related to resolution of the society for opening the said course not for profit etc has not given by the institution hance the same is required from the institution in the affidavit (format of the affidavit is enclosed herewith)

2. You are advised to remove/make good of the above deficiencies within a period of 60 days failing which your application will be treated as rejected and closed. It may be noted by the institution it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

3. Your reply/representation along with all necessary documents accompanied with an Affidavit in support the reply of the above points must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Rules & Regulations.
