The Institution has submitted approved building plan approved by Gram Panchayt but name of the proposed

course and khasra no of land is not mentioned on the building plan.

Notarized copy of change of land use certificate issued under clause 143 of UP land Act by the competent authority has not submitted.

The specific information of land/building, demarcated area as required in clause 8(7)(ii) and information required under clause 8(2) 8(3) of NCTE Regulations 2009 and information related to resolution of the society for opening the said course not for profit etc has not given by the institution hance the same is required from the institution in the affidavit(format of the affidavit is enclosed herewith).

You are advised to remove/make good of the above deficiencies within a period of 60 days failing which your application will be treated as rejected and closed.
