The Society/Trust has submitted an application through online mode on 31/12/2012 and physical application has been received in the office of NRC on 07/01/2013 for B.Ed. course in the proposed institution, by Shyam Baba Education, Plot No.0, Khasara No. 178, Street Number- 0, Village/Town- Sarendhi, Post office- Sarendhi, Tehsil/Taluka- Kheragarh, Town/City- Kheragarh, State- UP, District- Agra(UP), Pin Code -283121. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:-

- Originally notarized change of land use (CLU) certificate issued by SDM under Section 143 of the U.P. Land Act not submitted.
- ii. Affidavit in the prescribed format on Rs. 100/- Stamp paper not submitted.
- iii. The total land area not mentioned in the building plan.
- iv. The built-up area given in the building plan does not match with the application.
- Original FDRs of Rs. 5.00 lakhs and Rs. 3.00 lakhs towards endowment fund and reserve fund not ν, submitted.(Photocopy submitted)
- Seal of the approving authority not readable in the building plan. νi.
- Copy of the registered Trust Deed with names of office bearers to be submitted. The registration details of vii. the Trust are not clear from the copy of the Trust Deed submitted.
- The institution has also applied for B.Ed. course vide application no. 8030 and for D.El.Ed. course vide viii. Application No. NRCAPP 8045 for the academic year 2013-14 same plot no. As per clause 8(2) of the NCTE Regulations, 2009, only one application can be considered. Hence, clarification be given as to which of the applications be processed.
- The institution is also required to submit on Affidavit on Rs 100/- Stamp Paper as per format enclosed in ix. support of information required as per clause 8(2), 8(3) and 8(7) (2) of the NCTE Regulations, 2009 and Page-2, 4 and 5 of the online Application form.
- 2. You are advised to remove/make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.
- Your reply/representation along with all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.
- Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of the NCTE Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/processing fee cannot be made at any stage of application, whatsoever be the case.
