The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:-

Originally notarized change of land use (CLU) certificate issued by SDM under Section 143 of the U.P. Land

Act not submitted.

Only Khatoni submitted as land documents. Certified copy of registered land documents by Registrar/Subii. Registrar as required under provision of clause 8 (7) (i) of NCTE Regulations, 2009 is to be submitted.

Affidavit not submitted in the prescribed format. iii.

The memorandum showing names of office bearers with designation of the trust not submitted. iv.

Original FDRs of Rs. 5 lakhs towards endowment fund and Rs. 3 lakhs towards reserve fund not submitted. ٧. Only Photocopy submitted.

Total plot area and name of the institution not mentioned in the building plan. vi.

The building plan does not mention for which course the building has been constructed. vii.

The building plan has been approved by Gram Pradhan, Sarendhi, whereas the village name in the viii, application is Kasampur. The institution has submitted the same building plan as submitted in r/o file no. NRCAPP-8030 by changing plot no.

Copy of the registered Trust Deed with names of office bearers to be submitted. The registration details of the

Trust are not clear from the copy of the Trust Deed submitted.

The institution is also required to submit on Affidavit on Rs 100/- Stamp Paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of the NCTE Regulations, 2009 and Page-2, 4 and 5 of the online Application form.

You are advised to remove/make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential

documents as per provisions of the NCTE Act, Rules & Regulations.

Your reply/representation along with all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.

Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of the NCTE Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/ processing fee cannot be made at any stage of application, whatsoever be the case.
