The Society/Trust has submitted an application through online mode on 28/12/2012 and physical application has been received in the office of NRC on 02/01/2013 for B.Ed course in the proposed institution, IMS Girls College, Plot/Khasara No- 14, 16, 17, 24, Vill- Dhuri, Post Office- Pilkhuwa, Tehsil- Dhaulna, Distt-Ghaziabad, Pin Code-245304, UP. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:-

i. Originally notarized change of land use (CLU) certificate issued by SDM under Section 143 of the U.P. Land Act not submitted.

ii. Address of the institution given in the affidavit does not match with the application.

iii. The information at s.no.5 of the Affidavit is incorrect i.e. the no. and date of CLU is to be mentioned.

iv. Title of the land not mentioned clearly in s.no.3 of the affidavit.

v. The address of the trust in the land document does not match with the application.

vi. Original FDRs of Rs. 5.00 lakhs and Rs. 3.00 lakhs towards endowment fund and reserve fund from nationalized bank not submitted. The institution has submitted the photocopies of the FDRs.

vii. Building plan does not show for which teacher education course the building has been constructed.

viii. The address of the trust in the trust deed does not match with the application.

ix. The institution is also required to submit on Affidavit on Rs 100/- Stamp Paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of the NCTE Regulations, 2009 and Page-2, 4 and 5 of the online Application form.

2. You are advised to remove/make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTF Act, Rules & Regulations.

3. Your reply/representation along with all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.

4. Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of the NCTE Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/processing fee cannot be made at any stage of application, whatsoever be the case.
