It is informed that on preliminary perusal of the documents submitted with your application viz a viz provisions of the NCTE Regulation, 2009, your application is found deficient on the following points which are as under:-

- Certified copy of registered land documents issued by the competent authority (office of Registrar/ Sub Registrar) as required under provision of NCTE regulation, 2009 has not submitted.
- The name of the society and institution mention in the land documents and application does not match with each other.
- The institution has not submitted approved building plan in original. The original building plan III. approved by competent authority indicating name of Institution, name of the course, Khasra No./Plot No. of land, total land area & built up area, size of multipurpose hall, class rooms, library ,different resource centre etc as per NCTE norms for the proposed course is required to be submitted.
- Copy of change of land use certificate issued by the competent authority under clause 143 of UP iv. land Act is not notarized.
- The information in r/o SR No.-5 is not filled up properly in the affidavit of Rs. 100/-. ν.
- The specific information of land/building, demarcated area as required in clause 8(7)(ii) and vi. information required under clause 8(2) 8(3) of NCTE Regulations 2009 and information related to resolution of the society for opening the said course not for profit etc has not given by the institution hance the same is required from the institution in the affidavit(format of the affidavit is enclosed herewith).

You are advised to remove/make good of the above deficiencies within a period of 60 days failing which your application will be treated as rejected and closed. It may be noted by the institution it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

Your reply/representation alongwith all necessary documents accompanied with an Afficial support of the reply of the above points must be submitted within 60 days of issue of this letter; which appropriate action will be taken as per provisions of the NCTE Rules & Regulations.
