This has reference to the subject cited above, institution has submitted an application in online mode on 31.12.2012 and physical application has been received in the office of NRC on 07.01.2013 for D.El.Ed. (Girls) Course in the proposed institution i.e. Saraswati Mahila Mahavidyalaya, Plot No.- 02, Village- Kanpur, Post Office- H.N. 2. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulation 2009. It is informed that on preliminary perusal of the documents submitted with your application viz a viz provisions of the NCTE Regulation, 2009, your application is found deficient on the following points which are as under:-

- i. Fixed Deposit Receipt for Rs 5.00 lakes of Nationalized bank towards Endowment funds in original is required.
- ii. Fixed Deposit Receipt for Rs 3.00 lake of Nationalized bank towards Endowment funds in original is required.
- iii. Legible notarized change of land use (CLU) certificate issued by SDM under section 143 of UP Land Act is required.

iv. The information, regarding Sr. no. 5 is not mentioned on an affidavit of Rs. 100/-.

- v. Approved Building plan having demarcated land area and built-up area for proposed D.El.Ed. Course, existing B.Ed. course and other existing educational courses being conducted by institution is required to be submitted.
- vi. The institution is required to submit an Affidavit of Rs. 100/- stamp paper as per the format enclosed in support of information required as per clause 8(2), 8(3) and 8(7)(ii) of the NCTE Regulations 2009 & page 4 & 5 of the Online Application form.
- 3. You are advised to remove/make well of the above deficiencies within a period of 60 days failing which your application will be treated as rejected and closed. It may be noted by the institution it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.
- 4. Your reply/representation along with all necessary documents accompanied with an Affidavit in support of the reply of the above points must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Rules & Regulations.

5. Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/processing fee cannot be made at any stage of application, whatsoever is the case.
