The Society/Trust has submitted an application through online mode on 25/12/2012 and physical application has been received in the office of NRC on 27/12/2012 for increase in intake in B.Ed course in the existing institution, Dr Ram Monohar Lohia Institute, Plot No. 387 & 388, Khasara NO. 387 & 388, Street Number- 387 & 388, Village/Town- Sikri Kalan, Post office- Modinagar, Tehsil/Taluka- Modinagar, Town/City- Modinagar, State- UP, District- Ghaziabad (UP), Pin Code -210204. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:-

Land document submitted is not certified by Competent Authority. Certified copy of land documents registered by Registrar/Sub-Registrar is to be submitted.

CLU submitted is not originally notarized. Originally notarized change of land use (CLU) certificate issued by ii. SDM under Section 143 of the U.P. Land Act is to be submitted.

Total land area given in the Land document and CLU certificate does not match with the application. iii.

The plot/khasara no.357 Agiven in the Land document & CLU certificate does not match with the application. iv.

The information at s.no.5 of the affidavit is incorrect i.e. the no. and date of CLU certificate does not match with v. the CLU.

Building plan duly approved by the competent authority/local body indicating the name & address of the ν**i.** institution, Plot/Khasara No., total Plot area & built up area, name of the course to be submitted. The building plan submitted is not approved by the competent authority.

Title of the land not mentioned clearly in s.no. 3 of the Affidavit.
Clarification be given whether the B.P.Ed. course in rule on the land on plot nos. 387 and 388 or an a different viii. land & building.

The institution is also required to submit on Affidavit on Rs 100/- Stamp Paper as per format enclosed in support ix. of information required as per clause 8(2), 8(3) and 8(7) (2) of the NCTE Regulations, 2009 and Page-2, 4 and 5 of the online Application form.

You are advised to remove/make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

Your reply/representation alongwith all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.

Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of the NCTE Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/ processing fee cannot be made at any stage of application, whatsoever be the case.
