- The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulation 2009.  - The institution is running some other courses. Hence earmarked area of land and building is required. iv.
 - As per the Affidavit of Rs. 100/- the land is on lease basic. ν.
 - νi. The institution is required to submit an Affidavit of Rs. 100/- stamp paper as per the format enclosed in support of information required as per clause 8(2), 8(3) and 8(7)(ii) of the NCTE Regulations 2009 & page 4 & 5 of the Online Application form.
