The Society/Trust has submitted an application through online mode on 31/12/2012 and physical application has been received in the office of NRC on 04/01/2013 for B.Ed course in the proposed institution, Indian Institute of Excellence, Plot/Khasara No- 297/300, Vill- Khilwai/Dotai, Post Office- Khilwai, Tehsil-Garhmukteshwar, Distt- Ghaziabad, Pin Code-245205, UP. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:-

i. Originally notarized change of land use (CLU) certificate issued by SDM under Section 143 of the U.P. Land Act not submitted.

ii. Land document submitted are not certified by Competent Authority. Certified copy of land documents registered by Registrar/Sub-Registrar to be submitted.

iii. Dates of land registration given in the land documents are 19/07/2012 & 28/07/2011, but only 19/07/2012 mentioned in the Affidavit.

iv. The Affidavit submitted is not attested by the Oath Commissioner or Notary Public.

v. Khasara no. 281 given in the land documents does not match with the application.

vi. The building plan does not show for which teacher education course the building has been constructed.

vii. The built-up area given in the building plan does not match with the application.

viii. The address of the Society in the FDRs and Registration Certificate does not match with the application.

ix. As per land document in r/o plot no. 297 & 300, the land area is only 460 sq.mt, which is less as

per norms for the course.

x. As per records, the Society has applied for B.Ed. course in Institute of International Excellence (NRCAPP-9155) for 2013-14 on plot no. 281, Vill- Dotai, Post Office- Dotai, Distr- Ghaziabad. As per clause 8(2) of the NCTE Regulations 2009, "In the first instance, an institution shall be considered for grant of recognition of only one course for the basic unit as prescribed in the norms and standards for the particular teacher education programme. Hence, clarification be given.

i. The institution is also required to submit on Affidavit on Rs 100/- Stamp Paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of the NCTE

Regulations, 2009 and Page-2, 4 and 5 of the online Application form.

You are advised to remove/make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

3. Your reply/representation along with all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.

4. Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of the NCTE Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/processing fee cannot be made at any stage of application, whatsoever be the case
