The Society/Trust has submitted an application through online mode on 31/12/2012 and physical application has been received in the office of NRC on 07/01/2013 for B.Ed course in the proposed institution, Kashi Prasad Degree College, Plot/Khasara No- 1130, Vill- Kuthaunda, Post Office- Bangra, Tehsil-Madhogarh, Distt- Jalaun, Pin Code-285121, UP. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:-

- i. CLU submitted is not originally notarized. Originally notarized change of land use (CLU) certificate issued by SDM under Section 143 of the U.P. Land Act is to be submitted.
- ii. Land document submitted is not certified by Competent Authority. Certified copy of land documents registered by Registrar/Sub-Registrar is to be submitted.
- iii. Date of land registration not mentioned in the Affidavit.
- iv. Total land area given in the land document does not match with the application.
- v. The name of the institution in the land document and Affidavit does not match with the application.
- vi. The address of the society given in the FDRs does not match with the application.
- vii. The address of the society given in the Society Registration Certificate does not match with the application.
- viii. As per CLU, the land measuring 1.214H is in the name of Kashiprasad Upadhyaya Mahavidyalaya and 0.405H is in the name of Kashiprasad Upadhyaya Balika Inter College, and not in the name of the institution.
- ix. The building plan does not mention for which course the building has been constructed.
- x. The plot/khasara no. not mentioned in the building plan.
- xi. The institution is also required to submit on Affidavit on Rs 100/- Stamp Paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of the NCTE Regulations, 2009 and Page-2, 4 and 5 of the online Application form.
- 2. You are advised to remove/make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.
- 3. Your reply/representation along with all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.
- 4. Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of the NCTE Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/processing fee cannot be made at any stage of application, whatsoever be the case.
