It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations 2009, your application is found deficient on the following points which are as undert-

Originally notarized change of land use (CLU) certificate issued by SDM under section 143 of U.P. Land Act not submitted.

Land document submitted were not certified by competent authority. Certified copy of registered land 2. documents issued by the competent authority is to be submitted.

Khasara no. 380( in land documents it is 381) and Plot area given in the land document does not match with the application.

The building plan does not show for which teacher education course the building has been constructed.

The Seal of Pradhan, Gram Panchyat is not legible in the building plan.4 5.

The date of registration of land documents not mentioned in the information at S.No.2 of the affidavit.

Built up area and plot area given in the building plan does not match with the application.

Fixed Deposit receipt number in respect of FDRs of Rs. 5.00 lakhs and Rs. 3.00 lakhs does not match with the application

The institution is also required to submit an Affidavit on Rs 100/- stamp paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of NCTE Regulations, 2009 and Page 2,4 and 5 of the online application form.
