The Society/Trust has submitted an application through online mode on 31/12/2012 and physical application has been received in the office of NRC on 07/01/2013 for B.Ed course in the proposed institution, Vasundhara TT College, Plot/Khasara No- 518, Vill- Saray Dadan Uparhar, Post Office- Mandara, Tehsil-Soraon, Distt- Allahabad, Pin Code-228411, UP. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:-

i. Originally notarized change of land use (CLU) certificate issued by SDM under Section 143 of the U.P. Land Act not submitted.

ii. Land document submitted is not certified by Competent Authority. Certified copy of land documents registered by Registrar/Sub-Registrar is to be submitted.

iii. The address of society given in the FDRs, land document & Society Registration Certificate does not match with the application.

iv. Total plot area given in the land document does not match with the application.

v. Total land area & built-up area given in the building plan does not match with the application.

vi. Name of institution not mentioned in the building plan.

vii. The building plan not approved by the Competent Authority/Local body.

viii. The building plan does not mention for which course the building has been constructed.

ix. Information at s.no.2.1 & 2.2 in the affidavit not filled up.

x. Date of land registration not given in the affidavit

xi. The title of the land not clearly mentioned in s.no.3 of the Affidavit.

xii. Address of land registration office given in the affidavit does not match with the land document.

xiii. The information at s.no.5 of the Affidavit not filled up i.e. the no. and date of CLU is to be mentioned.

xiv. Valid print out of the online application bearing ID No. not submitted.

xv. The building plan is for school building and not for B.Ed. course.

xvi. The validity of registration of Society is not clear from the Registration Certificate of the society.

xvii. The institution is also required to submit on Affidavit on Rs 100/- Stamp Paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of the NCTE Regulations, 2009 and Page-2, 4 and 5 of the online Application form.

2. You are advised to remove/make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

3. Your reply/representation alongwith all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.

4. Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of the NCTE Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/ processing fee cannot be made at any stage of application, whatsoever be the case.
