The Society/Trust has submitted an application through online mode on 31/12/2012 and physical application has been received in the office of NRC on 07/01/2013 for D.El.ED course in the ND College of SC Tech Education, Plot No. 27, Nofari, Lodhai, P.O. Shyamo, Sadar, Dist. Agra 282001 (U.P.). The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations. 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations 2009, your application is found deficient on the following points which are as under:-

- 1. Name and address of the institution given in the FDRs does not match with the application.
- 2. Name of the institution given in the land documents does not match with the application.
- 3. The no. and date mentioned in the S. No. 5 of the affidavit is incorrect. The no. and date of the issue of CLU is to be mentioned.
- 4. As per application, the FDRs are Shreyas Gramin Bank, whereas the institution has submitted FDRs of Bank of India. Thus, the FDRs nos. and date do not match with the FDRs.
- The address of the institution in the building plan does not match with the application.
- Name of the course not mentioned in the building plan.
- 7. The name of the institution in the CLU does not match with the application.
- 8. The address of the institution in the affidavit does not match with the application.
- 9. The address of the Trust in the trust deed does not match with the application.
- 10. The institution is also required to submit an Affidavit on Rs 100/- stamp paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of NCTE Regulations,2009 and Page 2,4 and 5 of the online application form.
- 2. You are advised to remove /make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.
- 3. Your reply/representation along with all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.
- 4. Reply in piecemeal will not be accepted. Since application has been processed as per clause 6 of NCTE Regulations, 2009, hence, once the application is duly processed by this office, the claim for refund of application processing fee cannot be made at any stage of application, whatsoever be the case.
