The Society/Trust has submitted an application through online mode on 31/12/2012 and physical application has been received in the office of NRC on 07/01/2013 for D.El.Ed. course in the proposed institution, LN College, Plot/Khasara No- 58B, Vill- Dikhtauli, Post Office- Shikohabad, Tehsil- Shikohabad, Distt-Firozabad, Pin Code-283203, UP. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:-

1. Name of Trust given in the FDRs does not match with the application.

As per information given by the institution on P.4 of the application, the institution is conducting B.Ed. course. The complete details of the course i.e. whether it is being conducted on the same land and building on which the new D.El.Ed. has been proposed or on a different land and building.

Date of land registration given in the Affidavit does not match with the application.

4. The name of institution & plot/khasara no. given in the land document does not match with the application.

5. Total built-up area given in the building plan does not match with the application.

The institution has also applied for B.Ed. course vide application No. NRCAPP-9529 on plot no. 58A, Vill-Dikhtauli, P.O. Shikohabad, Distt- Firozabad. As per clause 8(2) of the NCTE Regulations, 2009, only one application shall be considered. Hence clarification be given as to which of the applications be processed. As per Clause 8(3) of NCTE Regulation 2009, an institution can apply for one basic unit only of an additional course or for an additional unit of the existing recognised course after completion of three academic sessions of the respective course, for which the Institution shall submit application before the cut off date prescribed for submission of applications in the year succeeding the completion of three academic sessions.

The institution is also required to submit on Affidavit on Rs 100/- Stamp Paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of the NCTE Regulations, 2009 and Page-2, 4 and 5 of the online Application form.

You are advised to remove/make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

Your reply/representation alongwith all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.

Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of the NCTE Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/ processing fee cannot be made at any stage of application, whatsoever be the case.
