The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:-

- 1. The institution has applied for B.Ed. course, application of which is not required to be processed by the NRC, NCTE due to negative recommendation received from the State Govt. except for the Minority Institutions. Hence, Minority Certificate issued by the competent authority under Article 30(1) of the Constitution of India declaring the institution as Minority Institution is required to be submitted.
- 2. Originally notarized change of land use (CLU) certificate issued by Competent Authority not submitted.
- 3. Original FDRs of Rs. 5.00 lakhs and Rs. 3.00 lakhs towards endowment fund and reserve fund from nationalized bank not submitted.
- 4. The information at s.no.5 of the affidavit is incorrect i.e. the no. and date of ChU certificate is to be
- The Registration Certificate of the society has expired. The renewed certificate copy be submitted.
- Plot/khasara nos. & total land area given in the land document does not match with the application.
- Blue Print of the building plan duly approved by the Competent authority/local body indicating name & address of the institution, total plot & built up area, name of the course to be submitted. The building plan submitted is not legible and does not have these details.
- The address of the institution in the Affidavit does not match with the application.
- 9. The institution is also required to submit on Affidavit on Rs 100/- Stamp Paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of the NCTE Regulations, 2009 and Page-2, 4 and 5 of the online Application form.
- You are advised to remove/make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.
- Your reply/representation alongwith all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.
- Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of the NCTE Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/ processing fee cannot be made at any stage of application, whatsoever be the case.
