The Society/Trust has submitted an application through online mode on 29/12/2012 and physical application has been received in the office of NRC on 31/12/2012 for B.Ed course in the proposed institution, Guru Teg Bahadur College of Education, Plot/Khasara No- M40, Vill- Mahiudinpur, Post Office- Golepura, Tehsil- Sahabad, Distt- Kurukshetra, Pin Code-135135, HR. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:-

- The institution has applied for B.Ed. course, application of which is not required to be processed by the NRC, NCTE due to negative recommendation received from the State Govt. except for the Minority Institutions. Hence, Minority Certificate issued by the competent authority under Article 30(1) of the Constitution of India declaring the institution as Minority Institution is required to be submitted.
- Originally notarized change of land use (CLU) certificate issued by Competent Authority not submitted.
- 3. Land documents submitted are not certified by Competent Authority. Certified copy of land documents registered by Registrar/Sub-Registrar is to be submitted.

4. Original FDRs of Rs. 5.00 lakhs and Rs. 3.00 lakhs towards endowment fund and reserve fund

from nationalized bank not submitted.

5. The name of Trust given in the land document, affidavit & Trust Deed is Guru Teg Bahadur Educational & Welfare Trust, whereas name of Trust given in the online application is Guru Teg Bahadur College of Education, which does not match.

Total land area given in the land document does not match with the application.

- The information at s.no.5 of the affidavit is incorrect i.e. the no. and date of CLU certificate is to be mentioned.
- 8. Information at s.no. 2.4 in the Affidavit, i.e. the khasara no. does not match with the application.

The khasara no. not given in the building plan.

10. The building plan does not mention for which course the building has been constructed.

11. The institution is also required to submit on Affidavit on Rs 100/- Stamp Paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of the NCTE Regulations, 2009 and Page-2, 4 and 5 of the online Application form

You are advised to remove/make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

Your reply/representation along with all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.

Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of the NCTE Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application processing fee cannot be made at any stage of application, whatsoever be the case.
