This has reference to the subject cited above, institution has submitted an application in online mode on 27.12.2012 and physical application has been received in the office of NRC on 03.01.2013 for D.El.Ed (Co.Ed) Course in the proposed institution i.e Jawahar Lal Nehru College Of Education, Plot No.- 524(Khasara no.- 1670,98,89, Khewat no.- 1563,1560), Village- Gohana, Post Office- Gohana, Tehsil/Taluka-Gohana, Dist.- Sonepat, State- Haryana- 131301.

2. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations 2009. It is informed that on preliminary perusal of the documents submitted with your application viz a viz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:-

i. Fixed Deposit Receipt for Rs 3.00 lake of Nationalized bank towards Endowment funds in original is required.

ii. The Institution has submitted Private lease deed, which is not permissible as per clause of 8(7)(i) of NCTE Regulations 2009.

iii. A Copy of approved Building plan having demarcated built-up area for proposed D.El.Ed. Course, existing course and other educational courses being conducted by institution at khasra no. / Plot no. 1560, 1563 is required to be submitted.

iv. Notarized change of land use (CLU) certificate issued by SDM under relevant section prevailing land Act of

Haryana State.

v. The information, regarding date of registration of land, on an affidavit of Rs. 100/- is not mentioned.

vi. A copy of Registration Certification of Society/Trust is not submitted.

vii. Institution is required to submit a copy of certificate issued by National Commission for Minority Educational Institutions granting minority status to proposed D.El.Ed course.

viii. The institution is required to submit an Affidavit of Rs. 100/- stamp paper as per the format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (ii) of the NCTE Regulations 2009 & page 4 & 5 of the Online Application form.

3. You are advised to remove/make good of the above deficiencies within a period of 60 days failing which your application will be treated as rejected and closed. It may be noted by the institution it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

4. Your reply/representation along with all necessary documents accompanied with an Affidavit in support of the reply of the above points must be submitted within 60 days of issue of this letter, failing which appropriate action will be

taken as per provisions of the NCTE Rules & Regulations.

5. Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of Regulations 2009, hence once the application is duly processed by this office, the claim for refund of application/processing fee cannot be made at any stage of application, whatsoever be the case.
