The Society/Trust has submitted an application through online mode on 31.12.2012 and physical application has been received in the office of NRC on 04.01.2013 for D.El.Ed. course in the proposed institution, S M College of Education, Plot No.-25/1/235, Street No.-B-C Road, Village- Chang, Post Office- Chang, Tehsil/Taluka – Bhiwani, Town/City- Bhiwani, District- Bhiwani -127021, State- Haryana. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time, it is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations 2009, your application is found deficient on the following points which are as under:-

The institution has applied for D.El.Ed. course, application of which is not required to be processed by the NRC, NCTE
due to negative recommendation received from the State Govt. except for the Minority Institution, hence Minority
Certificate issued by the competent authority under article 30(12) of the Constitution of India to declare the institution as
a Minority Institute is required to be submitted by the Institution

. The name of the authorized applicant in the application form did not appear in the Trust Deed. The institute is required

to clarify the same.

The land documents submitted by the institution are not certified by the concerned Revenue Authority/Tehsildar. Therefore, the institution is required submit the land documents clearly showing the land in possession of the institution

as per provision of clause 8 (7) of the NCTE Regulations, 2009.

4. The building plan submitted by the institution is not approved by the competent civil authority and same also do not mentioned plot no./khasra no and did not show the name of the course for which the building is meant for by the institution Therefore, the institution is require to submit a certified copy of the resolution/proceeding passed by the Gram Panchayat Sabha/Samiti that the area where the land & building of the proposed teacher training institution is situated does not comes under the Municipal Council/Dev. Authority or Notified area and the Gram Panchayat is authorized to pass the building plan.

The institution has not submitted notarized copy of change of land use certificate issued by the competent authority as per Regulation 2009. Hence the institution is required to submit notarized copy of change of land use certificate issued by

the competent authority.

The "Objective" of the trust/society under which the institution is proposed to run teacher education programme do not provide opening of the teacher education programme by the concerned trust/society. The institution is required to clarify the same

The land documents submitted by the institution are not attached with the "Najri Naksha" Which is essentially attached with every land documents at the time of registration of land documents by the Tehsil Authority. The Institution is required to clarify the same

The details regarding land & building mentioned in the Affidavit, land documents & building plan are not fully matching

with each other. The institute is required to clarify the same.

The institution is also required to submit an Affidavit on Rs.100/- stamp paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8 (7) (ii) of the NCTE Regulations, 2009 and page 2,4,5 of the online application form.

You are advised to remove /make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

3. Your reply/representation along with all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.

4. Reply in piecemeal will not be accepted. Since application has been processed as per clause 6 of NCTE Regulations, 2009, hence, once the application is duly processed by this office, the claim for refund of application /processing fee cannot be made at any stage of application, whatsoever been the case.
