It is informed that on preliminary perusal of the documents submitted with your application viz a viz provisions of the NCTE Regulation, 2009, your application is found deficient on the following points which are as under:-

- Certified copy of registered land documents issued by the competent authority (office of Registrar/ Sub Registrar) as required under provision of NCTE regulation, 2009 has not
- The institution has not submitted approved building plan in original. The original building plan approved by competent authority indicating name of Institution, name of the course, Khasra No./Plot No. of land, total land area & built up area, size of multipurpose hall, class rooms, library, different resource centre etc as per NCTE norms for the proposed course is required to be submitted.

Notarized copy of change of land use certificate issued under clause 143 of UP land Act by iii. the competent authority has not submitted.

The institute has subumitted print out of the application which is not valid print out of the iv. application. Hence valid print out of the application is required.

The institution has submitted land douciments on lease basis which is not acceptable as per clause 7(i) of Regulations 2009.

The specific information of land/building, demarcated area as required in clause 8(7)(ii) and information required under clause 8(2) 8(3) of NCTE Regulations 2009 and information related to resolution of the society for opening the said course not for profit etc has not given by the institution hance the same is required from the institution in the affidavit(format of the affidavit is enclosed herewith).

You are advised to remove/make good of the above deficiencies within a period of 60 days failing which your application will be treated as rejected and closed. It may be noted by the institution it is the sole responsibility of the institution to ensure proper compliance of all the essential documents
