- 3. The institution has not submitted approved building plan in original. The original building plan approved by competent authority indicating name of Institution, name of the course, Khasra No./Plot No. of land, total land area & built up area, size of multipurpose hall, class rooms, library ,different resource centre etc as per NCTE norms for the proposed course is required to be submitted.
- 4. Notarized copy of change of land use certificate issued under clause 143 of UP land Act by the competent authority has not submitted.
- 5. The specific information of land/ building, demarcated area as required in clause 8(7)(ii) and information required under clause 8(2) 8(3) of NCTE Regulations 2009 and information related to resolution of the society for opening the said course not for profit etc has not given by the institution hance the same is required from the institution in the affidavit(format of the affidavit is enclosed herewith).

You are advised to remove/make good of the above deficiencies within a period of both and a second s failing which your application will be treated as rejected and closed. It may be noted by the
