It is informed that on prolumnary perusal or the documents submitted with your application viz a-viz provisions of the NCTF Regulations 2009, your application is lound deficient on the following points which are as under-

Certified copy of registered land documents issued by the Registrar/Sub-registrar as required under clause 8(7)(i)
of NCTE Regulations, 2009 not submitted. The institution has submitted only Khatoni as land document.

2. The building plan duly approved by Competent Gavt. Authority/Local body, not submitted.

- 3. The name of the institution given in the building Plan and affidavit plan does not match with the application.
- 4. The building plan does not show for which teacher education course the building has been constructed.

5. Bailt up area given in the bailding plan does not match with the application.

- 6. The address of the society given in the registration certificate does not match with the application.
- Fixed deposit receipt of ks. Five takhs and ks. Three kakhs in original from Nationalized Bank towards Endowment Fund and reserve fund not submitted.
- 8. Date of registration of land documents not mentioned in the information at S.No.2 of the Affidavit.
- 9. The Affidavit submitted by the institution is not in the prescribed format. Hence, the Affidavit in the prescribed format be submitted.
- 10. As per application the Society is also running Institute of Professional Studies for Bachelor of Education course. The complete details of this institution be submitted i.e. whether the equive is being run on same land and building where the B.Ed course has been proposed or at a different location.
- 11. The institution has submitted only two sets of application. As per NCTE Regulations, 2009, three sets of the application are to be submitted.
- 12. The institution is also required to submit an Affidavit on Rs 100/- stamp paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of NCTE Regulations, 2009 and Page 2.4 and 5 of the value application form.
- 2. You are advised to remove make good the above deficiencies within a period of 60 days. It may be noted by the insulation that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.
- 3 Your reply/representation along with all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act. Rules & Regulations.
- 4. Reply in piecemeal will not be accepted.
