This has reference to the subject cited above, institution has submitted an application in online mode on 31.12.2012 and physical application has been received in the office of NRC on 04.01.2013 for B.Ed. course in the proposed institution by Landmard Institute of Management And Technology, Plot/Khasra Number-446 Street Number-Didauli, Village-Didauli, Post Office-Didauli, Tehsil/Taluka-Amroha, Town/City-Amroha, District-Jyotiba Phule Nagar(UP), State-Uttar Pradesh, Pin Code-244222. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulation 2009. It is informed that on preliminary perusal of the documents submitted with your application viz a viz provisions of the NCTE Regulation, 2009, your application is found deficient on the following points which are as under:-

- i. Original FDRs of Rs. Five Lakh and Three Lakh of nationalized bank towards Endowment fund and Reserved Fund respectively has not submitted.
- ii. Certified copy of registered land documents issued by the competent authority (office of Registrar/Sub Registrar) as required under provision of NCTE regulation, 2009 has not submitted.
- iii. As per land documents submitted by the institution the land is taken on lease basis from managing society, which cannot be considered as per provision of clause 8 (7) (i) of NCTE Regulation, 2009. only Govt. land can be considered on lease basis.
- iv. The institution has not submitted approved building plan in original. The original building plan approved by competent authority indicating name of Institution, name of the course, Khasra No./Plot No. of land, total land area & built up area, size of multipurpose hall, class rooms, library , different resource centre etc as per NCTE norms for the proposed course is required to be submitted.

The information given in affidavit related to CLU in point no. 5 is not correct.

The specific information of land/ building, demarcated area as required in clause 8(7)(ii) and information required under clause 8(2) 8(3) of NCTE Regulations 2009 and information related to resolution of the society for opening the said course not for profit etc has not given by the institution hance the same is required from the institution in the affidavit(format of the affidavit is enclosed herewith).

You are advised to remove/make good of the above deficiencies within a period of 60 days failing which your application will be treated as rejected and closed. It may be noted by the institution it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.
