This has reference to the subject cited above, institution has submitted an application in online mode on 31.12.2012 and physical application has been received in the office of NRC on 04.01.2013 for B.ED. course in the proposed institution i.e. Ravindra Nath Tagore Education College, Plot/Khasra Number-265,266,267,260, Street Number- NH-24, Village- Khungawali, Post Office- Gajraula, Tehsil/Taluka-Hasanpur, Town/City- Gajraula, District- Jyotiba Phule Nagar(UP), State- Uttar Pradesh, Pin Code-244235. The said application was placed before NRC in its 217th Meeting held form 26th July to 29th July, 2013 and it was decided that file be processed further. It is informed that as per decision of NRC on preliminary perusal of the documents submitted with your application viz a viz provisions of the NCTE Regulation, 2009, your application was found deficient on the following points which are as under:-

- Original FDRs of Rs. 5 lack and 3 lack of Nationalized bank towards Endowment fund and Reserved Fund respectively has not submitted.
- The institution has not submitted approved building plan in original. The original building plan approved by competent authority indicating name of Institution, name of the course, Khasra No./Plot No. of land, total land area & built up area, size of multipurpose hall, class rooms, library, different resource centre etc as per NCTE norms for the proposed course is required to be submitted.
- The name of authorized applicant in the application form doesn't appear in the bye-laws of the
- The name of the society/trust is Shri Ganpati Charitable of Welfare Trust whereas the land is in favour of Ganpati Charitable of Welfare Trust. Hence land title is not in favour of the Society/Trust as required in clause 8(7)(i) of NCTE Regulations 2009.

The institution has submitted another application NRCAPP- 8790 & 8838 which is against as per clause 8 (2) (3) of regulation 2009.

Phe specific information of land/ building, demarcated area as required in clause 8(7)(ii) and information required under clause 8(2) 8(3) of NCTE Regulations 2009 and information related to resolution of the society for opening the said course not for profit etc has not given by the institution hence the same is required from the institution in the affidavit(format of the affidavit is enclosed

In terms of above decision, the above deficiencies are hereby again communicated to you with advise to remove/make good of the above deficiencies within a period of 60 days failing which your application will be treated as rejected and closed. It may be noted by the institution it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.
- 4. Your reply/representation along with all necessary documents accompanied with an Affidavit in support of the reply of the above points must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Rules & Regulations.
- 5. Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/processing fee cannot be made at any stage of application, whatsoever be the case.
