The Society/Trust has submitted an application through online mode on 14/12/2012 and physical application has been received in the office of NRC on 20/12/2012 for B.Ed course in the proposed institution, Vimla Vikram Mahavidyalaya, Plot No. 607, 608, Village - Pachperwa, P.O. Balrampur, Tah. Tulsipur, Dist. Balrampur - 271 206 (U.P.). The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:-

Originally notarized change of land use (CLU) certificate issued by SDM under Section 143 of the U.P. Land Act not submitted.

FDRs submitted are not of the Nationalized Bank. FDRs of Rs. 5 lakhs towards endowment fund and 3 lakhs ii.

towards reserve fund in original of the nationalized banks is to be submitted.

The application of the applicant institution bearing Code No. NRCAPP2391 for B.T.C. course is under process. iii. The course has been applied on plot/khasara no. 606, 607, 608. Pachperwa, Balrampur, Lucknow. As per Clause 8(2) of NCTE Regulations 2009 only one application shall be considered for grant of recognition.

The Institution is also conducting B.Ed. Programme as per information submitted in the on-line application. Clarification be given whether the existing institution is conducting the programme on the same land on which įν.

the proposed course has been applied or on different land.

The institution is also required to submit on Affidavit on Rs 100/- Stamp Paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of the NCTE Regulations, 2009 and Page-2, 4 and 5 of the online Application form.

You are advised to remove/make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

Your reply/representation alongwith all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.

Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of the NCTE Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/ processing fee cannot be made at any stage of application, whatsoever be the case.
