It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations 2009, your application is found deficient on the following points which are as under:-

- 1. The building plan does not show for which teacher education course the building has been constructed.
- 2. Clear and legible copy of the land documents be submitted. The certified copy submitted by the institution is not legible.
- 3. The approval of the building plan has expired on 5/8/2012.
- 4. The address of the institution in the building plan does not match with the application.
- 5. As per application the Society is also running Agra Vanasthali Mahavidyalaya for B.Ed course. The complete address of this institution be submitted.
- 2. The institution is also required to submit an Affidavit on Rs 100/- stamp paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of NCTE Regulations, 2009 and Page 2,4 and 5 of the online application form.
- 3. You are advised to remove /make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

4. Your reply/representation along with all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.

5. Reply in piecemeal will not be accepted. Since application has been processed as per clause 6 of NCTE Regulations, 2009, hence, once the application is duly processed by this office, the claim for refund of application /processing fee cannot be made at any stage of application, whatsoever been the case.
