Recommendation of the State Government in respect of application received by NRC, NCTE for Sub.: recognition of teacher education course - reg.

Sir/Madam,

As you are aware, as per the provisions of the National Council for Teacher Education Act., 1993, an institution proposing to conduct a course or training in teacher education is required to seek recognition from the National Council for Teacher Education. For this purpose, the institution is required to make an application in the prescribed format together with processing fees and other documents to the concerned Regional Committee of the NCTE as per the regulations.

Towards this the National Council for Teacher Education has promulgated regulation 2014 with regard to recognition norms and procedure. As per provision 4 to Section 7 of the Regulations 2014 notified in official Gazette on 01/12/2014, a copy of the application form submitted by an institution shall be sent to the State Government/ U.T. Admn. concerned. On receipt of the communication the State Government/U.T. Admn. Concerned, shall furnish its recommendation on the application to office of the Regional Committee concerned of the National Council for Teacher Education within 45 days from the date of issue of the letter to the State Government/Union Territory. In case, the State Government/Union Territory Administration is not in favour of recognition, it shall provide detailed reasons or grounds thereof with necessary statistics, with shall be taken into consideration by the Regional Committee concerned while disposing of the application.

In accordance with the above, a copy of the application form submitted by the 26 (Twenty Six only) Societies/Institutions (List attached) to the Northern Regional Committee seeking grant of recognition for conducting teacher training programme (as per list enclosed) are sent herewith along with the request that the recommendation of the State Government may be furnished to the Regional Committee within 45 days.
