Admn. rned, shall furnish its recommendation on the application to office of the Regional Committee concerned of ational Council for Teacher Education within 45 days from the date of issue of the letter to the State nment/Union Territory. In case, the State Government/Union Territory Administration is not in favour of nition, it shall provide detailed reasons or grounds thereof with necessary statistics, with shall be taken into leration by the Regional Committee concerned while disposing of the application.
