The Society/Trust has submitted an application through online mode on 14/12/2012 and physical application has been received in the office of NRC on 19/12/2012 for B.Ed course in the proposed institution, Rameshwar Dayal Educational Institute, Khasra No. 738, Plot No. 56, NH58 Post Office- Duhai, Tah. Ghaziabad, Pin Code 201206 (U.P.). The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-aviz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:-

Original FDRs of Rs. 5.00 lakhs and Rs. 3.00 lakhs towards endowment fund and reserve fund from nationalized bank not submitted.

The building completion plan submitted is for R.D. Engineering College. The building plan approved by the ii. competent authority indicating complete address of the institution, total plot area, built-up area for the proposed course and name of the course, is to be submitted. As per clause 8(7) (ii), the teacher education institution shall not be allowed to have any other institution within its demarcated area or building and shall not have any other course (s) in its building

Originally notarized change of land use certificate for the khasara/plot no. as per application, from the Ghaziabad iii.

Development Authority to be submitted.

The address of the trust in the trust deed does not match with the application. iv.

The memorandum showing names of office bearers with designation of the trust not submitted.

The institution besides sale deed has submitted a rent agreement between Rameshwar Dayal Educational Trust and νi. Rameshwar Dayal Educational Trust in respect of residential school measuring land area 10000sqmt. and built-up area 1771.27sqm. on k.no 738, village- duhai, pargana- jalalabad, teh & distt- Ghaziabad. The details of this land and built-up area have been given in the application and affidavit, which means that the institution proposes to run B.Ed. course in the same building in which it is running the school. Certificate/letter from the district authorities that no school is running in this building be submitted.

The institution is also required to submit on Affidavit on Rs 100/- Stamp Paper as per format enclosed in support of vii. information required as per clause 8(2), 8(3) and 8(7) (2) of the NCTE Regulations, 2009 and Page-2, 4 and 5 of the

online Application form.

You are advised to remove/make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

Your reply/representation alongwith all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.

Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of the NCTE Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/ processing fee cannot be made at any stage of application, whatsoever be the case.
