The Society/Trust has submitted an application through online mode on 29.12.2012 and physical application has been received in the office of NRC on 02.01.2013 for B.Ed. course in the proposed institution BPS College, Plot No.-420, Street No.-0, Village- Pilona, P.O.- Pilona, Tehsil/Taluka - Mawana, Town/City - Meerut, District - Meerut, State - Uttar Pradesh-250401. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations 2009, your application is found deficient on the following points which are as under:-

- The building plan submitted by the institution did not show the name of the course for which the building is meant for by the institution. Therefore, the institution is require to submit building plan in blue print approved by the competent civil authority clearly showing the name of the institution, course, Khasra/Piot No., total land area & built up area, multipurpose hall, different resource centre, class room, library etc. as per provisions of the NCTE Regulations, 2009.
- The document shown as CLU is not notarized properly with full signature of notary public, name and registration of the same.
- As per details submitted by the institution the institution is running 6 Nos. of education programme. However the building plan submitted by the institution do not show demarcated land & built up area for each of the existing running educational programme as wel as proposed teacher education programme. The institution is required to submit a detailed demarcated site plan showing each of the existing running educational programme as well as details of proposed educational programme duly verified by the concerned Tehsildar/SDM.
- 4. The details of land as per the application form, Affidavit & CLU are not matching e.g. the CLU mentioned tow Khasra No. whereas the application shows one Khasra No. The affidavit mentioned Khasra No. 220 whereas the application mention plot No. 420. The institution is required to clarify the same.
- The institution is also required to submit an Affidavit on Rs 100/- stamp paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of NCTE Regulations, 2009 and Page 2,4 and 5 of the online application form.
- You are advised to remove /make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.
- Your reply/representation along with all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.
- Reply in piecemeal will not be accepted. Since application has been processed as per clause 6 of NCTE Regulations, 2009, hence, once the application is duly processed by this office, the claim for refund of application /processing fee cannot be made at any stage of application, whatsoever been the case.
