Sir/Madam,

The Society/Trust has submitted an application through online mode on 17/12/2012 and physical application has been received in the office of NRC on 18/12/2012 for B.Ed course in the proposed institution, Buhda College of Education, Plot/Khasara No- 614/3...& 638, Vill- Moja Fareedpur Kazi, Post Office- Bijnor City, Tehsil- Bijnor, Distt- Bijnor, Pin Code-246701, UP. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:-

- i. Originally notarized change of land use (CLU) certificate issued by SDM under Section 143 of the U.P. Land Act is to be submitted.
 - ii. Name of the Proposed course not mentioned in the building plan.
 - iii. The Memorandum showing names of office bearers with designation of the Trust not submitted.
 - iv. The land area given in the application does not match with the land documents. It is not clear that the land area of 10740 sq.m. is in respect of which of the plot nos.
 - v. The plot/khasara nos. given in the application do not match with the land documents.
 - vi. Document from the competent authority indicating that the plot nos. as mentioned in the application are adjacent to each other.
 - vii. No land document has been submitted in respect of plot no. 637.
 - viii. The plot nos. mentioned in the Affidavit do not match with the application and building plan.
 - ix. The dates of all registered land documents in respect of plot nos. whose area is 10740 sq.m., not mentioned in s.no. 2 of the Affidavit.
 - x. The information at s.no. 5 of the affidavit is incorrect i.e. the no. and date of CLU certificate is to be mentioned.
 - xi. As per Bye-laws of the Trust, the educational institutions and hospitals shall be opened by the Trust by the name of 'Genesis', whereas the proposed institution's name is Budha Institute of Education.
 - xii. The institution is also required to submit on Affidavit on Rs 100/- Stamp Paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of the NCTE Regulations, 2009 and Page-2, 4 and 5 of the online Application form.
2. You are advised to remove/make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.
3. Your reply/representation alongwith all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.
4. Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of the NCTE Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/ processing fee cannot be made at any stage of application, whatsoever be the case.
