The Society/Trust has submitted an application through online mode on 18/12/2012 and physical application has been received in the office of NRC on 20/12/2012 for B.ED course in the proposed Sri Ganga Memorial Girls Degree College, Plot/Khasara No. 89Min, Plot No. -89Min, Street Number-FZD Road, Vill-Paisar, Post Office- Head Post Office, Teh/Taluk- Nawabganj, Town/City- Barabanki, Dist- Barabanki, State-UP, Pin-225001. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations 2009, your application is found deficient on the following points which are as under:-

> 1. Originally notarized change of land use (CLU) certificate issued by SDM under section 143 of U.P. Land Act not submitted.

2. The Plot nos. in the land documents do not match with the application.

3. The land area in respect of the Plot no. 89MIN is 0.142H only which is less as per norms for the course

4. The Plot area in the land document in respect of plot no. 89MIN and building plan does not match with the application.

5. Built up area in the building plan does not match with the application.

Name of the course not mentioned in the building plan.

The address of the Trust does not match with the application.

Proof of deposit of processing fees by credit card not submitted.

As per Resolution of the Gram Panchayat dated 6/7/2010, the Society is running B.A. Programme in the same building in which B.Ed course has been proposed. As per clause 8(7)(ii) of the NCTE Regulation, 2009, the teacher education institution shall not be allowed to have any other institution within its demarcated area or building and shall not have any other course(s) in the building.

The institution is also required to submit an Affidavit on Rs 100/- stamp paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2)

of NCTE Regulations, 2009 and Page 2,4 and 5 of the online application form.

You are advised to remove /make good the above deficiencies within a period of 60 days. It may noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.
