This has reference to the subject cited above, institution has submitted an application in online mode on 27.12.2012 and physical application has been received in the office of NRC on 30.01.2013 for B.Ed. Course in the proposed institution i.e Prabhat Training Academy, Plot No.- 96, Village – Lohangpur, Post Office – Biharganj, Tehsil–Sadar, Dist.—Pratapgarh, State–Uttar Pradesh – 320502.

- 2. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulations 2009. It is informed that on preliminary perusal of the documents submitted with your application viz a viz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:
 - i. Land area mention in land document does not match with land area mentioned in copy of building plan.
 - ii. Location of land is over written in copy of building plan.
- iii. Originally notarized change of land use (CLU) certificate issued by SDM under section 143 of UP Land Act not submitted.
- iv. A copy of Registration Certificate of society/ trust is not submitted.
- v. The institution has not submitted affidavit of Rs. 100/- by oath commissioner or notary public.
- vi. The institution has corrected from Savita Jan Kalyan Society to Savita Jan Kalyan Trust by hand.
- vii. The society name in the building plan is Savita Jan Kalyan Trust whereas the name of the society is Savita Jan Kalyan Education trust.
- viii. The society name mentioned in the application form is not matching with building plan and land document.
- ix. The institution is required to submit an Affidavit of Rs. 100/- stamp paper as per the format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (ii) of the NCTE Regulations 2009 & page 4 & 5 of the Online Application form.
- 3. You are advised to remove/make good of the above deficiencies within a period of 60 days failing which your application will be treated as rejected and closed. It may be noted by the institution it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.
- 4. Your reply/representation along with all necessary documents accompanied with an Affidavit in support of the reply of the above points must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Rules & Regulations.
- 5. Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of Regulations 2009, hence once the application is duly processed by this office, the claim for refund of application/processing fee cannot be made at any stage of application, whatsoever be the case.
